Increase in multi-person households in 2022

Of more than 4 mio. private households, 2.5 mio. are multi-person households

Vienna, 2023-03-17 – In 2022, there were 4 067 000 private households in Austria, including 2 521 000 multi-person households, according to calculations by Statistics Austria based on the Microcensus Labour Force Survey. A total of 1 546 000 people lived alone.

"Austria's population has grown strongly in 2022. This is also reflected in the number and structure of private households: In particular, there was a significant increase in the number of multi-person households, with a plus of 27 000 compared with the previous year. Overall, the number of private households in Austria increased by 48 000 in 2022. The last time there was such a high increase was in 2015 and 2016," says Statistics Austria Director General Tobias Thomas.

The population in private households grew by 94 000 persons (+ 1.1%) on an annual average from 2021 to 2022 and now stands at 8 901 000 persons. The number of private households has also increased by 48 000 (+ 1.2%) and now stands at 4 067 000.

Multi-person households increased more than single households in 2022

The number of multi-person households increased by 27 000 in 2022, more than the number of single households (+21 000). Since 2004, this has only been the case in the years 2015 to 2017 – in all other years, the annual increases were mainly among single households. One reason for this development is the high level of immigration: In 2022, there was an annual average of 31 000 private households with at least one person who immigrated to Austria in 2022. The majority of these were multi-person households (88.2% or 28 000 households). In fact, around 10 000 households were exclusively inhabited by persons who had immigrated to Austria in 2022. The majority of these were also multi-person households (62.3% or 6 000 households).

Forms of cohabitation are changing

For many people, the term household conjures up the image of a couple with one or more children. However, taking together married couples and consensual unions with at least one child, only 26.7%, i.e. 1 087 000 of the 4 067 000 private households corresponded to this image in 2022. Overall, the proportion of couples with children is declining: In 1985 it was 37.9% and in 2000 33.5%.

Compared to other forms of cohabitation, couples with children nevertheless represent the most common type among family households. About a quarter of all private households (25.5%) are couples living without children in the household, 6.5% are single-parent households. Two or more families live together in only 1.3% of private households.

Among non-family households, single-person households are the most prevalent (38.0% of all private households). On the other hand, non-family multi-person households (e.g. shared apartments), hardly play a role (2.0% of all private households).

Information on methodology, definitions:

Married couples and consensual unions with or without children (living in the same household) as well as single-parent families constitute a (nuclear) family in the sense of the family statistics. In the definition of family statistics, children are all biological, step- or adopted children living with their parents or one parent in the same household, who do not have their own partner in the household and do not yet have children themselves - regardless of their age.

The results presented here are data from the Microcensus Labor Force Survey. The Microcensus is a sample survey of private households that interviews approximately 1 500 households each week. The population in institutional households is not part of the Microcensus Labour Force Survey.
